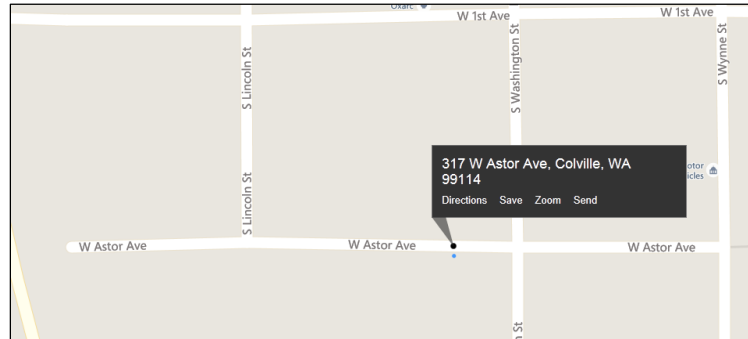

Map and Directions to Northeast Fairgrounds/Ag Trade Center

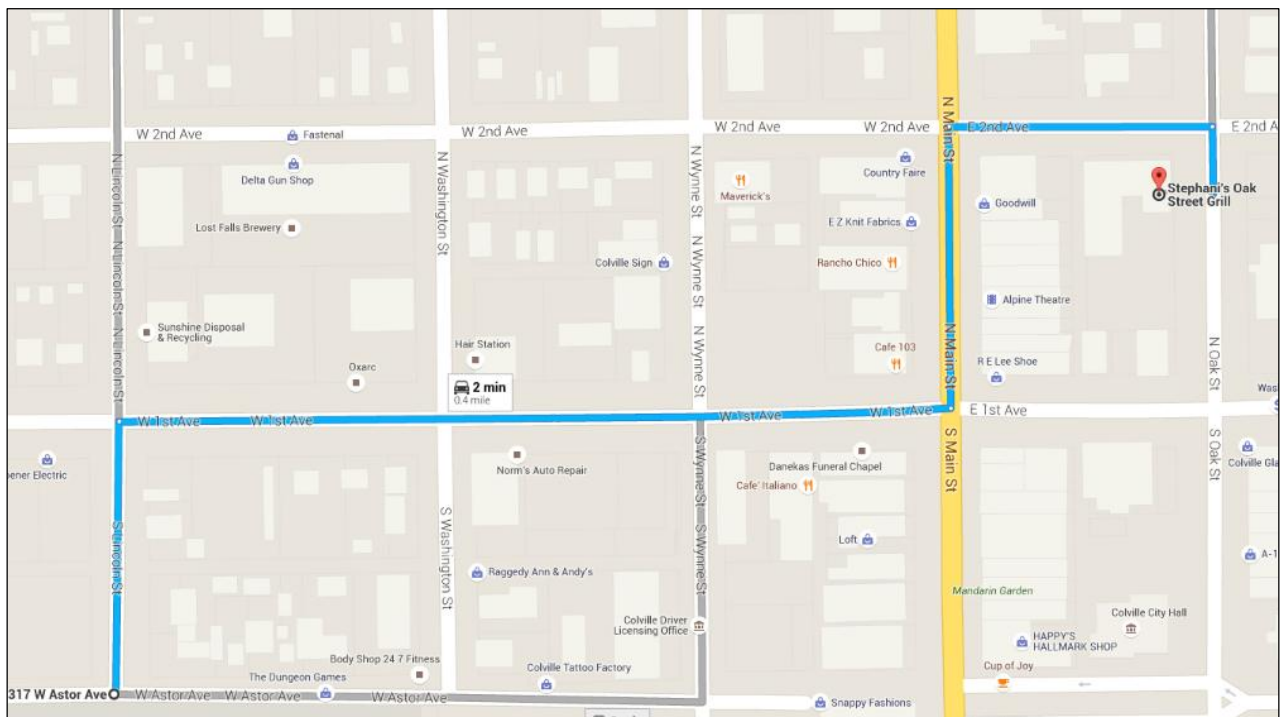
