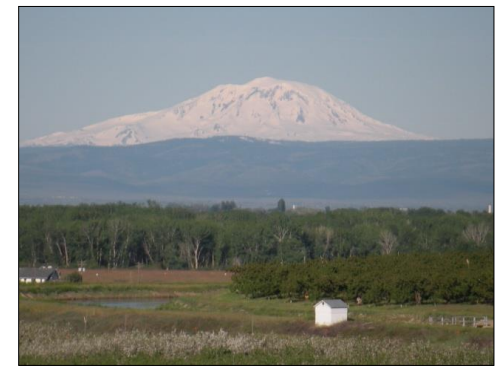

### Mission of the North Yakima Conservation District

- To enhance and promote the wise use of natural resources; promote sustainable, profitable agriculture; and improve the quality of life and culture in Yakima County by:
  - Encouraging good land stewardship through education, incentives, and quality technical assistance.
  - Support private property rights.
  - Building strong coalitions with other groups and governmental entities.
  - Including, but not limited to, government assistance as a valid conservation partner to agriculture, by providing quality, technical assistance to cooperators and partners.

### Natural Resource Priorities

#### ▪ Ag Preservation-Urban Interface-Land use planning

- **Natural resource priority description:** Address all SWAPAH (“soil, water, air, plant, animal and human”) related issues affected by development or changes in land use. Priority is to maintain current land uses by development of alternative options/programs while maintaining “working lands”.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, Yakima County has identified Farmland Preservation as a priority, Washington State has programs that protect farm and ranch lands, Washington State Conservation Commission have the Office of Farmland Preservation and the Natural Resources Conservation Service has several programs dedicated to farm and ranch land protection. Many non-profits organizations operate in the state seeking to maintain farm and ranch lands. indicate supporting information:
- **Source of data relied upon to indicate the resource concern:** Observation of land use changes within the county and resulting natural resource impacts. Program development by local, state, federal and non-profit groups. Data and print information from these same groups.
- **Other entities engaged in addressing this resource concern:** NRCS, Washington State, Washington State Conservation Commission, Yakima County, Resource Conservation Office and American Farmland Trust.

#### ▪ Water Resources (Water Quality and Water Quantity)

- **Natural resource priority description:** Water Quality Degradation in NYCD water bodies and Water Quantity issues throughout NYCD and the Yakima River Basin
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, 303d list and multiple local, state and federal plans identify water quality issues. Many local, State and Federal plans identify the need for water conservation

and storage including the “Yakima Basin Integrated Plan”. General field observations at the reach level and concerns raised by local landowners also support this resource priority.

- **Source of data relied upon to indicate the resource concern:** NYCD’s participation in and awareness of the above mentioned “planning” processes, 303d list, landowner observations
- **Other entities engaged in addressing this resource concern:** Washington State Department of Ecology, Washington State Conservation Commission, Yakama Nation, Bureau of Reclamation, Irrigation Districts, Yakima County, Commodity Groups, etc...

#### ▪ Fish and Wildlife

- **Natural resource priority description:** Many species of animals, fish, plants and their habitats are listed throughout the NYCD.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, there are several listings that are of a high priority including Steelhead and Sage Grouse. Other species that are of concern include Bull Trout and Pacific Lamprey. These species are of concern at the State, Federal and Tribal level throughout the Yakima River Basin.
- **Source of data relied upon to indicate the resource concern:** Federal and State listings, participation in planning forums, etc...
- **Other entities engaged in addressing this resource concern:** All effected partner entities such as NRCS, Forest Service, National Marine Fisheries Service, Washington Department of Fish and Wildlife and the Bureau of Reclamation, etc...

#### ▪ Livestock Issues (AFO, CAO, DNP and local issues where fencing, off-site watering, etc... can address the Natural Resource Concern)

- **Natural resource priority description:** Livestock (including hobby farms) and the livestock industry are important to the economy and culture of NYCD. As such they represent important natural resource opportunities and issues that need voluntary assistance and cost-share.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, Statewide the Dairy Nutrient Management Planning issue is of high concern. TMDL and Critical Area Protection through the Voluntary Stewardship Program implementation will “target” livestock issues and opportunities.
- **Source of data relied upon to indicate the resource concern:** The current ECY Ag/Water Advisory Committee process, TMDL processes, Critical area concerns from local and State entities and the Voluntary Stewardship Program Plan..
- **Other entities engaged in addressing this resource concern:** At this time only a few entities are engaged in the use of voluntary actions to protect natural resources from livestock use they include Conservation Districts, WSCC, WSU –Extension, Natural Resource Conservation Service, Farm Bureau, Washington Cattlemen Association and other commodity groups, whereas there is a larger list of State, Federal and Tribal Nations and special interest groups promoting the use of regulatory actions and litigation to address the issue. The new VSP Plan will guide the implementation of this concern.

#### ▪ Forestry

- **Natural resource priority description:** Forest health is failing throughout the State and fuels loading issues are the major concern of fire risk within the NYCD. The result of fire affects other NYCD priority concerns and should be considered a critical concern.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, the Department of Natural resources recently released reports of poor forest health throughout the State, the Highway 410/12 CWPP identifies fuels loading as a major concern within that planning area making this a local, regional and State priority.
- **Source of data relied upon to indicate the resource concern:** DNR reports on forest health and the Highway 410/12 CWPP as well as other CWPP processes.
- **Other entities engaged in addressing this resource concern:** Washington State Department of Natural Resources, Highway 410/12 planning group, US Forest Service, WSCC, Conservation Districts and local landowners.

▪ **Rangeland**

- **Natural resource priority description:** Shrub-Steppe habitats make up a large part of the working lands throughout the NYCD and are at risk of fire, improper grazing and conversion to non-compatible uses.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, Shrub-Steppe habitats are of concern at a local, State and Federal level due to conversion. Locally, fire risk has been identified as a major concern that affects other resource priorities.
- **Source of data relied upon to indicate the resource concern:** Shrub-Steppe Conservation Plans from many governmental entities and NGO's.
- **Other entities engaged in addressing this resource concern:** Shrub-Steppe Partnership, Conservation Districts, Department of Defense, Washington State Department of Fish and Wildlife, US Fish and Wildlife Service, Washington Cattlemen and private landowners.

▪ **Noxious Weeds and Pests.**

- **Natural resource priority description:** Noxious weeds exist throughout the NYCD. Several pests severely impact the areas agricultural viability to produce quality products and to ship those products.
- **Is this a state and or regional natural resource priority along with being a local priority?** YES, Yakima County annually lists noxious weeds that impact landowners throughout the NYCD. Currently, Apple Maggot quarantines exist throughout the State and impact the entire Apple industry of the State.
- **Source of data relied upon to indicate the resource concern:** Professional input from responsible entities.
- **Other entities engaged in addressing this resource concern:** WSU-Extension, Yakima County Horticultural Pest Control Board, Yakima County Weed Control Board, USDA-ARS, and Apple Commission.

**Funding Source(s):** Bonneville Power Administration, Yakima Tributary Access and Habitat Program, NYCD assessment, Salmon Recovery Funding Board, Yakima Basin Fish and Wildlife Recovery Board, US Department of Defense, RCO, Office of Farmland Preservation, Yakima County, WDFW, The Nature Conservancy, Cowiche Canyon Conservancy Washington State Conservation Commission and Recreation and Conservation Office..

**Natural Resource Measurable Result Objective: Develop and Establish Conservation Easements on 150 acres.**

**Programmatic Measurable Result Objective: Two (2) contracts for CE's will be completed. Required MOA's and supporting plans, agreements, and contracts will be established.**
